Questionnaire were distributed among 140 drug addicts whereas 120 addicts are answered. Qualitative data are collected through observation with open-ended questions. Five point scale are for each statements. They are Strongly disagree (SD), Disagree (D), Can't say (CS), Agree (A), Strongly agree (SA).




Figure 1. Science of living perceived through the mind of the drug addicts for youth empowerment

The findings of this study are analyzed through their domains (Science of living perceived through the senses of the drug addicts, Science of living perceived through the mind of the drug addicts, Science of living perceived through the morality of the drug addicts, Science of living perceived through the social of the drug addicts, Science of living perceived through the individual of the drug addicts) as given below:

# Science of living perceived through the senses and mind of the drug addicts

Around 75% of the respondents reported that they believed the youth empowerment through training as the guidance of commandment of Allah swt and the sunnah of Rasul S.A.W. They got an opportunity for self-expression. 91% of the respondents agreed the science of living workshops benefited them. The respondents felt that they have developed a greater respect for themselves (Figure 1 and Table 3).

The aim of this study was to determine the science of living through mental and spiritual of specific regional areas like as *kolej komuniti hulu Langat (kkh) Selangor and sahabat insan dan iman Malaysia (sidim)* where *kkh* contained technical education for youth employment for empowering through a holistic way prescription from Quran and Hadith in the Malaysian.

At that time, it was not considered harmful and there was no restriction or taboos as to its usage (Kamarudin, 2007).

Different types included for this analysis as demographic, economic, social as well as religious development for improving character through developing mentality for goodness and to work heartily in the same manner with etiquette and social explanatory variables. Discussing the contributing for the increased of youth employment for empowering through a holistic way prescription from Quran and Hadith paid policy applied for the addicts training and as well as students themselves. Here is attention to the level of technical education of young people. It is found that the risk of becoming unemployed is lesser for those who are strongly educated or have education after all. It is also arrived at the conclusion that the public employment policy measures.

On the one hand, the National Anti-Drugs Agency will use data like crime statistics and household income levels to streamline its campaigns (NADA, 2014).

As a result, identified the most significant issues are affecting the increased of youth employment for empowering through a holistic way prescription from Quran and Hadith and by which justified the youth empowerment. It should not be ignored when developing regional stissues gies for social-economic, social as well as religious development for improving character through developing mentality for goodness and to work heartily in the same manner with etiquette development and regional employment programs. The share of the correlation manufacturing sector in the economies of the regions of the sixth group is higher than in other KKH (Kolej Kumunity Hulu Langat), Selangor and SIDIM (Sahabat Dan Iman Malaysia), Rawang and the growth of the share of the employed in this kind of economic, social as well as religious development for improving character through developing mentality for goodness and to work heartily in the same manner with etiquette activity helps reduce the issues of youth employment for empowering through a holistic way prescription from Quran and Hadith. Those who do not have basic general education tend to join the ranks of unskilled labor for match up their lives. The results of our study show that the high level of technical education is a competitive advantage on the labor market. There are some training workshops available worldwide for implementing science based education that have tremendously helped teacher cum counselors develop skills to create a science and spiritual based environment through Quran and Hadith. It is promoting, inspiring and active listening for the addicts classes and session interesting and lasted long with wholly enjoy and happy lives of the addicts taking full activation on job. Their participation in all the activities is in employment to fulfill their commitment individually, socially and in the same manner and etiquettes.
